

## How the Partnership of Prayer Works with Enterprises of Influence

Whether the partnership is of a scholarship nature for interns or in the form of value attribution for graduates who have entered their profession as a corporate intercessor, both avenues give the enterprise a concentrated thirty minutes of prayer along with a weekly prayer report. The prayer report, which we believe operates as a petition includes the date and time the intercessor prayed, 2-3 highlighted prayer points, a prayer of the week and a daily question.

- Petitions are a formal written request appealing to authority with respect to a particular cause.
- Weekly prayer petitions allow for Matthew 18:19 to have its effect. The petition is recorded and then the recipient may read what was prayed and in turn say yes in agreement with it.
- The prayer of the week gives every leader being prayed for a verbal opportunity to pray a 5-10 second prayer highlighted to the intercessor. The recipient is encouraged to pray this as often as is remembered.
- The daily question's purpose is to promote communion between the recipient and God. Asking a question presents an opportunity for a reply to come. It also is a key method in directing focus. It is our hope that the recipients ask the question, and then pause in expectation of an answer from God. This communion opportunity can be a quick blessing from heaven or turn into a longer time of connecting with our dear Friend and Father.

**Biblical:** All our intercessors pray from biblical passages highlighted by the Holy Spirit. This way we are not tempted to pray out of our emotions, instead are grounded in the Word of God. You will find the scriptures that were prayed from, placed at the end of every bulleted prayer point.

**Daily Emails:** The elite partnerships include daily emails. These can be used for daily devotionals both for agreement on the petitions and for looking up the scriptures prayed to get current revelation for your day. Daily emails are sent at a time of your choosing.

**Micro and Macro prayers:** We train our intercessors to pray both micro and macro prayers. Micro prayers are dealing with specific prayer requests of the recipients, which deal directly with their sphere of influence. Macro prayers are praying from a larger viewpoint. For example, if the enterprise asks for prayer regarding a meeting that week, the intercessor might pray for all the meetings of Christian enterprises that are happening in that particular city, so that clarity and wisdom would be released. Now did the enterprise benefit? Yes! And others also! This allows our intercessors and our partners to integrate a global perspective, outside of ourselves.

**Confidentiality:** All prayer requests and all reports go directly to the SHIFT team manager. There is no direct communication between the recipient and the intercessor. We believe this keeps both parties safe and helps to guard confidentiality. Only the first name of the recipient is used. Company name and last names are kept concealed from the intercessors.

## Our Story

A new generation is developing a disciplined prayer-life composed of an excellence and understanding of what God is doing in the world outside of the church building. Marketplace leaders are transforming a generation into solid and powerful praying warriors. In addition we are seeing these marketplace leaders growing in their own prayer lives through the report structures that serve to coach leaders in their own prayer times. No longer will we see Christian businessmen and women isolated or ostracized because of their calling. A mighty outpouring of Holy Spirit is coming to the marketplace and we need these leaders in place to be catalysts and facilitators when this happens.

The elite professional partnership gives the enterprise a minimum of ten hours of prayer support a month by a *SHIFT-certified* intercessor, daily and weekly reports, plus monthly connection either by phone or in person with a *SHIFT* team manager.

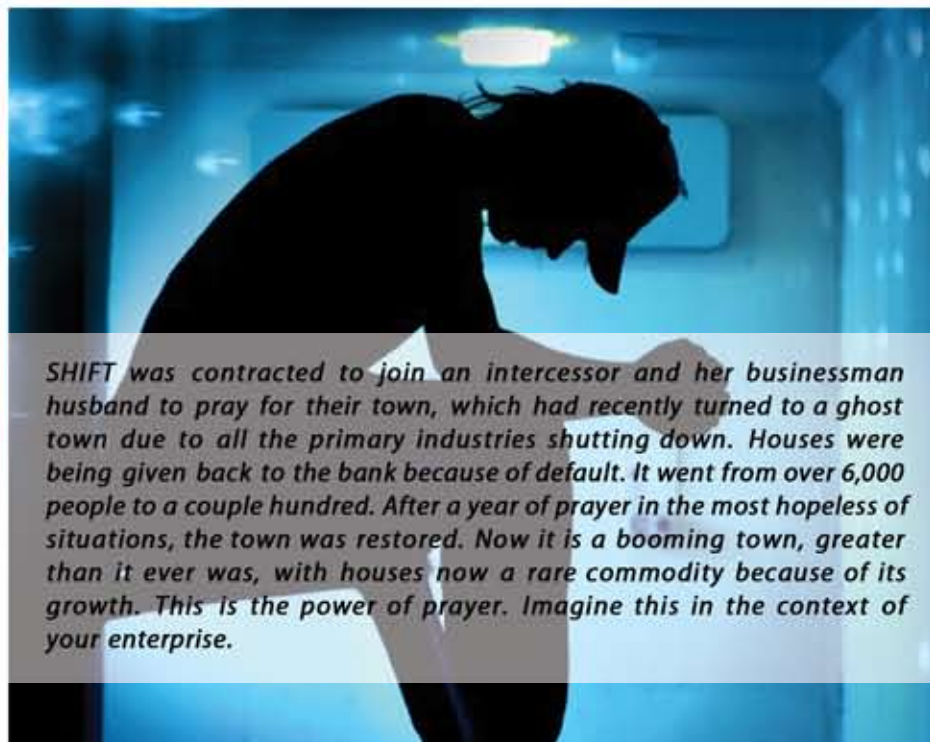

*SHIFT was contracted to join an intercessor and her businessman husband to pray for their town, which had recently turned to a ghost town due to all the primary industries shutting down. Houses were being given back to the bank because of default. It went from over 6,000 people to a couple hundred. After a year of prayer in the most hopeless of situations, the town was restored. Now it is a booming town, greater than it ever was, with houses now a rare commodity because of its growth. This is the power of prayer. Imagine this in the context of your enterprise.*

### Sponsor an Intern of Intercession

#### Our Cooperative Scholarship Program

- Scholarships are for the purpose of investing in the further education of students of intercession for the accomplishment of certain program goal. For example: a "Diploma of Intercession."
- For students who:
  - i. Have successfully completed "Introduction to Intercession"
  - ii. Demonstrate excellence and passion for growing in the profession of intercession.
- Monies will cover the tuition expenses and give a monthly allowance to the intern.
- Investors will receive ten hours of prayer each month and weekly prayer reports.

#### Share Prayer

- This is an affordable option for small businesses who want to sponsor an intercessor where they share the price and the time with another business. They receive a weekly report and 15 minutes of prayer a day, which equals 5 hours a month. Neither business will have access to the other business' information as the reports are given separately to protect confidentiality.
